

* The Duffy House is a center chimney, 5x2-bay, $2 \frac{1}{2}$ -story, side-gabled form with a hipped roof and elements of the Federal style; a rear ell is built perpendicular to the main block and connects the house to the 19th century barn

- * Decorative features include the center entry and symmetrical facade, corner boards and molded cornice
- * Windows are 6/6 double-hung sash with beaded trim; the center entry is not visible from the road
- * The rear ell is a 1-story gabled block with wood shingle roof and a stout brick chimney rising form the ridge
- * The barn is a 2-story gable roofed form clad in vertical flushboard; roofing material is wood shingles; a pyramidal roofed cupola with weathervane tops the roof ridge
- * The setting is the commercialized intersection of State Route 119 and Forge Village
- * The house retains its form and detail and is well-maintained

The house at 797 Boston Road was owned in 1832 by John Hancock Loring according to Butler's map of that year which also states he owned the Ridge Hill Tavern at 1 Forge Village Road (MHC #57). Mr. Loring was a vice president of the 1855 town bicentennial celebration and remained at 797 Boston Road until at least 1856 as his name appears at the site on the Walling map of that year. Census information from 1850 indicates he owned 11 acres and had property valued at \$4500, a slightly higher than average amount. Mr. Loring grew few crops at that time. A subsequent owner by 1875 was John Fuzzard who, like Mr. Loring, also owned the nearby tavern and later added the house at 15 Forge Village Road (MHC #58) to his property. He owned the house until at least 1889 as his presence is reflected on the county atlas from that year. Lawrence Duffy, a mill hand, owned the house by 1930 and appears to have kept in in good condition and the surrounding land planted in hay according to the 1939 WPA map.

The Federal Style Loring-Duffy House at 797 Boston Road is potentially eligible for the National Register of Historic Places as an individual resource at the local level. The house was owned in 1832 by John Hancock Loring according to historian Caleb Butler's map of that year which also states Mr. Loring owned the Ridge Hill Tavern at 1 Forge Village Road (MHC #57). Mr. Loring was a vice president of the 1855 town bicentennial celebration and remained at 797 Boston Road until at least 1856 as his name appears at the site on the Walling map of that year. The farm remained in agricultural use until the 1930s according to maps drawn by the WPA in 1939. The building's associations with historic agricultural activity in Groton establish its significance under Criterion A. The design of the well-maintained house's symmetrical façade, hipped roof and attached barn make the property eligible under Criterion C. The house retains integrity of design, materials and workmanship.
