

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

* The Victorian Eclectic style house at 19 Champney Street is a 2 1/2-story, cross-gabled form of 3x4 bays; the front and southwest side of the first story are covered by a nearly flat-roofed porch with prominent cornice supported by square piers with molded caps and a balustrade

* Details include the gable returns, corner boards, molded cornice and deep eaves

* Windows are 2/1 double-hung sash with slim hoods; the opening in the front gable peak has a tripartite example with the center sash flanked by shorter 1/1 sash

- * The off-center entries have plain trim and are located at the southwest and southeast corners
- * The detached two bay gable front garage appears to have been built in the mid 20th century
- * The house is well-maintained and is typical of Champney Street

Champney Street was laid out shortly after publication of the 1889 atlas of Middlesex County. By 1930, the owner of 19 Champney Street was Abram Miller according to the map of Groton printed in that year. The 1918 resident directory lists Mr. Miller as Abraham and gives his occupation as a watchman at Groton School. The 1929 resident directory states he was married to Julia and they lived on the end of Champney Street near Main Street.
