



Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

* The house and barn at 24 Higley Street occupy an open flat parcel of formerly agricultural land; The side-gabled, 5x2-bay, 2story house has elements of the Cape Cod form and Federal style; a 2-story ell of four bays projects off the back of the house and connects to the gable front barn

* Decorative features of the house are the symmetrical fenestration in the façade, corner boards, gable returns and molded cornice

* Windows in the façade are 12/12 double-hung sash with beaded trim; Elsewhere, they are mainly 6/6 units with corner blocks in the trim; modern casement windows also exist

* The main center entry also has beaded trim with Victorian style corner block; Sidelights further accentuate the doorway;

Additional entries are in the south elevation of the main block and of the rear ell which contains a modern door

* Brick chimneys rise from the center of the main roof ridge and from the ridge of the rear ell

* The barn is clad in wood clapboards on the façade, wood shingles in the gable peak and on the side walls; the principal elevation has only a vehicle door for access to the interior although a pedestrian door exists adjacent to it in the shed that connects the house

* The house and barn are well-maintained and continue to suggest a strong connection to Groton's agricultural past

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners /occupants played within the community.

The earliest map showing a house on this site is from 1856 and depicts William Kilburn at this location. Federal census schedules from 1850 list him as having 28 acres, \$1500 in property, a horse and a cow. State census records from 1855 list him as an 82 year old farmer. By 1875, A. E. Parkhurst was here according to the 1875 county atlas. This may be Albert Parkhurst who owned 32 acres, a farm worth \$3000 with a horse and 4 cows. Mr. Parkhurst remained until at least 1889 according to the atlas from that year. The 1930 owner was Mrs. John Lawrence who also owned houses at 112, 133, 154 Farmers Row (MHC #s 194, 85 and 379) in addition to the neighboring building at 20 Higley Street (MHC ###). By 1939, the farmland was in use as pasture. Higley Street appears to have been named for Edward Higley, a teacher at Groton School according to the 1888 resident and busienss directory for Ayer and Groton.
