

- * The house at 54 Hill Road is a 5x2-bay, 2 1/2-story, side-gabled form with elements of the Colonial style
- * Decorative features are minimal but include the symmetrical fenestration in the façade, corner boards and molded cornice
- * An addition of 2 stories containing a garage has been made to the rear (north) and a second addition of 1 story to the east side elevation
- * Windows are 6/9 double-hung sash with plain trim
- * The center entry has 1/2-length sidelights and plain trim that appears to heave been added after original construction
- * The house is in fair condition and appears to be vacant
- * The outbuildings are not visible from the road
- * The large parcel of open land presents a rural aspect
- * An interior examination could reveal more details about the period of construction

The first known owner of the house at 54 Hill Road is Osgood Putnam in 1828-29 when Caleb Butler recorded in his field notes that the house had its current form and was painted yellow. Mr. Putnam's name appears on the 1847 and 1856 maps of Groton and he is listed as a farmer with 10 children in 1855 census schedules. Non-population Census Schedules from 1850 list him as a farmer with 150 acres, a wide variety of livestock, and \$3,500 in hops, a large amount confirmed in Richardson's narrative although Mr. Putnam grew no hops by 1860, reflecting the westerly trend in cultivation of that crop. Mr. Putnam appears in the same year as a manufacturer of wire cloth with one emplyee and working by hand-power. Richardson also notes that Mr. Putnam later moved to 182 Farmers Row (MHC #86). The 1875 owner was C. Parsons and by 1889, it was occupied by C. H. Hill. This may be Charles Hill whose widow and daughter Bessie, a school teacher, were listed as residents of the neighborhood in the 1918 and 1929 resident directories and on the 1930 Tercentenary Map. Stony and plowable pasture as well as hay fields are depicted on the property on the 1939 WPA map of Groton. Miss Bessie Hill lived at the house until the 1960s and was known as a nature lover and instructor of the subject in New York City and at the Lowthorpe School of Landscape Architecture for Women, located at 14 Main Street (MHC #20) where she had charge of the school gardens.
