ARCHITECTURAL	DESCRIPTION	

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

- \* The house at 40 Hollis Street is a 5x3-bay, 2 1/2-story, side-gabled form with elements of the Federal style; it appears that a gabled rear ell was added perpendicular to the main block to connect to the garage, forming a staggered L-shaped plan; an enclosed shed porch was also added to the south elevation
- \* Ornamental elements include the gable returns, corner boards and symmetrical fenestration in the façade
- \* Windows are 6/6 double-hung sash with beaded trim
- \* The center entry has an entablature over the transom and paneled pilasters that flank the door's sidelights
- \* Paired brick chimneys rise from the rear roof slope
- \* The well-maintained building occupies a small parcel in the town center and is of similar scale and materials to its neighbors

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners /occupants played within the community.

The 1832 Butler map may depict John Hartwell as the owner although houses are close enough together here to prevent certainty. Mr. Hartwell's name is associated with the house on the 1847 Butler map as well, although he sold the property by 1856 to G. Shattuck. This is George Shattuck according t state census records which also state he was born c. 1809 and worked as a merchant. Mr. Shattuck sold to A. Spaulding by 1875 who remained here until at least 1889. This is likely Andrew Spaulding who is listed in the 1888 resident directory as a constable living on Hollis Street. The 1901 Sanborn map labels the barns as "Farm barns", suggesting an agricultural use for the Groton Center property. By 1921, it had been built into the current configuration with one of the rear ells in use as an auto house. The 1930 owners were Mary and George H. Pierce who worked in trucking.
