

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

* The Federal style house at 356 Main Street s a side-gabled, 5x3-bay, 2 1/2-story form with a 1 1/2-story ell and connected shed projecting from the northeast elevation; The house is oriented perpendicular to the road; Decorative features consist of the symmetrical fenestration, classical surround at the center entry, closed gable, molded cornice, corner boards and beaded window trim; The 3-sided bay has paneled pilasters at the corners and full entablature supporting the flat roof

- * Windows are mainly 6/6 double-hung sash with fixed 12 and 4-pane sash in the bay
- * Three tall brick chimneys occupy all but the southwest corner of the main roof

Access to the ell is via a pair of swinging doors in the southwest elevation positioned below a fixed 6-pane sash

* The detached barn appears to possess dimensions suggestive of an 18th century English barn, approximately 30'x40' and is oriented with the eave side toward the road; Vehicle access is through rolling doors lit from above by a transom; additional openings contain small fixed sash and a pedestrian door; siding is vertical flushboard; additional gabled masses can be seen at the southeast corner of the barn but are unidentifiable from the road

* The house and barn are well-preserved and retain integrity of materials and design; the site is elevated slightly above Main Street a short distance northwest of the town center

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners /occupants played within the community.

Butler's 1832 map of Groton has John Simonds at this location and says in his field notes from 1828-1829 that was an "old" 1story, 1-chimney form with 2 windows across the façade, a much smaller building than currently exists, suggesting the house was rebuilt shortly afterward. By 1847, Joshua Gilson (born c. 1797; married to Ann) was the owner and he probably occupied the current building. Mr. Gilson remained here until at least 1889 and was recorded in agricultural census records of 1850-1870 as having between 25 and 90 acres, 1 horse and 1 or 2 cows and a farm worth \$4000, an amount slightly above average. On the 1889 county atlas, Mr. Gilson is shown as owning both this and the neighboring house at 368 Main Street (MHC ###). Dr. Green notes he was an organizer of the 1855 town bicentennial and a justice of the peace in 1858. By 1939, the farm was wellmaintained and planted in hay, crops and orchards. The 1930 owner was the farmer W. H. Whitehall.




