

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

* 430 Old Ayer Road is a 4x1-bay, 2 1/2-story, side-gabled, Federal style house with a rear shed-roofed addition of 2 stories that is enlarged by a shed dormer; A gabled porch has been added to the south elevation of the shed addition

* Ornamental features are the molded cornice, gable returns and corner boards

* Windows are 2/2 double-hung sash with plain trim

* The off-center entry has classical trim including fluted pilasters and denticulated cornice that appear to be modern reconstructions

- * The detached 1-bay, gable front garage is quite small and is clad in wide clapboards
- * The house appears to enjoy extensive views to the west that may include Mout Wachusett

HISTORICAL NARRATIVE

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners /occupants played within the community.

The Butler field notes of 1828-1829 describe the house at or near this location as an "old" example of a 2-story form with 1 chimney and three windows across the front. Architectural details and trim suggest the house was built or significantly altered after that date. By 1856, the farmer Alvah Wright, a neighboring farmer who lived at 416 Old Ayer Road (MHC ###), owned both properties according to the Walling map of Middlesex County. This continued to be true until at least 1875, the year the Beers county atlas was published and reflected his ownership of both buildings. By 1889, however, Mr. Wright's name appears associated with only this farm and he had sold the farm at 416 Old Ayer Road to an owner named Black. The 1930 owner was Helen M. Nimmo. By 1939, the farm was planted in market garden produce.
