

\* The house at 54 Pleasant Street is a 5x1-bay, side-gabled, 2 1/2-story Greek Revival style design with a 2-story rear ell and enclosed entry porch at the east side of the ell

\* Decorative elements include the symmetrical fenestration in the façade, closed gable, corner pilasters, frieze and molded cornice

- \* Windows are mainly 6/6 double hung sash with plain trim except for the opening in the gable peak which has a 3/6 sash
- \* The center entry has sidelights and a classical surround including pilasters and entablature
- \* The house is in good condition and retains integrity of materials, design and setting

The owner of the house depicted on the 1847 Butler map of Groton may be G. Pierce, the proximity of other buildings making it difficult to ascertain. The same is true for the 1856 map although by the time of the 1875 county atlas, it seems clear the owner was S. Russell. The 1889 county atlas depicts S. Fletcher as the occupant. This is Solomon Fletcher, a farmer and Pleasant Street resident listed in 1888 resident directory. By 1921, the attached barn was in use as an auto house. The 1930 owner was Mary Fletcher, widow of Solomon Fletcher.
